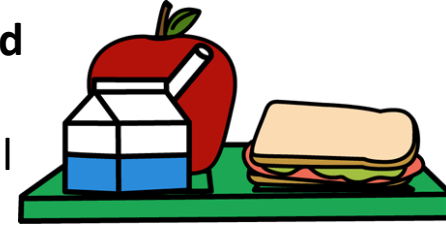


ST. JOHN. SUMMER FEEDING PROGRAM

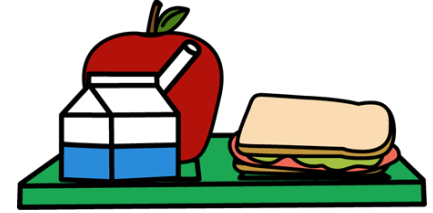
