AMENDMENT NO. 2 TO PROFESSIONAL SERVICES AGREEMENT FOR GRASS CUTTING SERVICES

This Agreement is made and entered into on this 14th day of July, 2020 between **St. John the Baptist Parish Council**, hereinafter referred to as "**Parish**", represented by **Jaclyn Hotard, Parish President**, in accordance with the duly passed motion of the St. John the Baptist Parish Council and **B&D Tractor Services, Inc., 510 Palm St., Laplace, LA 70068** represented by **Kerry Brignac** in accordance with the corporate resolution attached hereto, hereinafter referred to as "**Contractor**" under the following terms and conditions.

AMENDMENT

The "Amendment" Section of the original Agreement executed on December 13, 2018, provides that "this agreement may be amended by written consent, executed by both parties and subject to approval of the St. John the Baptist Parish Council."

In accordance with the "Amendment" Section of the original Agreement, Amendment No. 1 provided that the parties agreed to exercise the option to amend the Agreement by adding two new sites, effective the date of execution.

Accordingly, Amendment No. 2 provides that the parties hereby agree to exercise the option to amend the Agreement by adding two new sites and five annual services, effective the date of execution.

PAYMENT TERMS

In accordance with the "Amendment" Section of the original Agreement, the parties hereby agree to amend the Pricing Schedule, attached as **Exhibit A: Pricing Schedule**.

Except as set forth in Amendment No. 2, all terms and conditions not addressed herein shall remain as stated in the December 13, 2018 Agreement.




