EXTENSION NO. 1 FOR DISASTER RESTORATION AND RECOVERY SERVICES

This Agreement is made and entered into on this 9th day of June, 2020, between **St. John the Baptist Parish Council**, (hereinafter referred to as "Parish"), represented by Jaclyn Hotard, **Parish President**, in accordance with the duly passed motion of the St. John the Baptist Parish Council and **Emergency Restoration Inc., P.O. Box 10889, New Orleans, LA 70123, (504) 736-0472**, represented by **Michael Orlando**, Chairman in accordance with the certified resolution attached hereto, (hereinafter referred to as "Contractor") under the following terms and conditions.

TERM OF CONTRACT

The term of contract of the original Agreement executed on July 28, 2017 provides that "This Contract shall begin on the date referenced on the first page of this document and shall be for a term of three (3) years. The Parish may extend the term of this contract for one (1) year by written notice to the Contractor within thirty (30) calendar days of its termination date." and subject to approval by St. John the Baptist Parish Council.

The parties hereby mutually agree to exercise the option to extend the original Agreement referenced as Extension No. 1 which shall commence on July 29, 2020 and terminate July 28, 2021.

Except as set forth in this Extension, all terms and conditions not addressed herein shall remain as stated in the original contract dated July 28, 2017.
