A Cooperative Endeavor Agreement
Between
St. John the Baptist Parish Government
And
New Wine Christian Fellowship Church

WHEREAS, this partnership agreement between St. John the Baptist Parish Government and New Wine Christian Fellowship Church is for the 2017 St. John the Baptist Parish Summer Food Service Program Satellite Site.

WHEREAS, Article 7, Section 14 of the Louisiana Constitution allows for political subdivisions and/or corporations to enter into cooperative endeavor agreements in order to expend public funds for a public purpose resulting in a benefit to the public; and

WHEREAS, the purpose of this agreement is to ensure that low-income children within our Parish continue to receive nutritious meals when school is not in session; and

WHEREAS, The Summer Food Service Program will operate from June 5, 2017 through July 13, 2017. New Wine Christian Fellowship Church will permit usage of the following location as a satellite feeding site:

- New Wine Christian Fellowship Church Kitchen

WHEREAS, St. John the Baptist Parish Government will handle all planning for the Summer Food Service Program and provide adequate personnel, supplies and transportation to fulfill and maintain all program requirements.

NOW THEREFORE, BE IT RESOLVED, that St. John the Baptist Parish and New Wine Christian Fellowship Church agree to work together from the date this Cooperative Endeavor

Agreement is signed until July 13, 2017 when the 2017 Summer Food Service Program concludes.
