AMENDMENT

The "Amendment" Section of the original Agreement executed on December 13, 2018, provides that "this agreement may be amended by written consent, executed by both parties and subject to approval of the St. John the Baptist Parish Council."

The parties hereby agree to exercise the option to amend the original Agreement by adding a new site, effective the date of execution.

PAYMENT TERMS
