On Wednesday, April 3, 2019, ST. JOHN THE BAPTIST PARISH COUNCIL announces its intent to request approval from the United States Department of Agriculture (USDA) for use of the:

- ❖ 2019 SFSP Waiver # SFSP 12-2011, that would set aside regulatory sponsor requirements to conduct SFSP site visits during the first week of program operations for sites that operated successfully in the previous year. And,
- ❖ 2019 SFSP Waiver #SFSP 06-2017, that would establish for continued use of Offer versus Served (OVS) meal pattern at all open program sites being used for the program. The anticipated 2019 SFSP Sites will be identified by St. John Parish school district in May, 2019.
